PARTICULARS OF CLAIM

 On or about the 24th day of September, 2020, the King Makers' Committee of Zazzau (Zaria) Emirate Council selected the Plaintiff as the Emir of Zazzau having scored the highest number of lawful votes cast by the Kingmakers. The scores of each of the Three (3) persons who were shortlisted out of the total number of those who showed interest read:

- 2. The 1st Defendant was and still is at all material times mandated and is under a statutory duty to appoint the Plaintiff being the person selected by the King Makers' Committee as the Emir of Zazzau.
- 3. Under the Chiefs (Appointment and Deposition) Law of Kaduna State, the Governor of Kaduna State (the 1st Defendant) has no right whatsoever to appoint any person other than the person selected by the King Makers' Committee.
- 4. The 1st Defendant (The Governor of Kaduna State) was and is still mandated to appoint the Plaintiff as the Emir of Zazzau having been so selected by the Zazzau Emirate King Makers' Committee.
- 5. In a flagrant disobedience to the Chiefs (Appointment and Deposition) Law of Kaduna State, the 1st Defendant unilaterally and unlawfully appointed the 11th Defendant (Ambassador Ahmad Nuhu Bamalli) who was not even among the 3 candidates who were shortlisted after thorough screening by the King Makers' Committee as the purported Emir of Zazzau.
- 6. The Plaintiff is by operation of law deemed appointed as the Emir of Zazzau within 14 (fourteen) days after the Plaintiff's selection by the King Makers' Committee on the 24th September, 2020, notwithstanding the 1st Defendant's refusal to appoint him as such.

ENDORSEMENT

The Plaintiff claims against the Defendants jointly and severally as follows:

a. A DECLARATION that the Plaintiff to the exclusion of the 11th Defendant has been duly and properly selected as the Emir of Zazzau (Zaria) by the King Makers' Committee of Zazzau Emirate in accordance with the provisions of the Chiefs (Appointment and Deposition) Law of Kaduna State and Zazzau Native Law, Custom and Tradition on the 24th day of September, 2020;

- b. A DECLARATION that the unilateral appointment of the 11th Defendant as the Emir of Zazzau (Zaria) on the 7th day of October, 2020, by the 1st Defendant when the 11th Defendant was not selected at all by the King Maker's Committee of Zazzau Emirate, contravenes the mandatory provision of the Chiefs (Appointment and Deposition) Law Cap 21 Laws of Kaduna State, rendering the said appointment irregular, unlawful, unconstitutional, unjust, inequitable and contrary to good conscience, and is therefore null, void and of no legal effect whatsoever;
- c. A DECLARATION that the Plaintiff having been selected as the Emir of Zazzau by the King Makers' Committee of Zazzau Emirate on 24th day of September, 2020, is entitled under the Chiefs (Appointment and Deposition) Law of Kaduna State, to be appointed by the 1st Defendant (Governor of Kaduna State) as the Emir of Zazzau;
- d. A DECLARATION that having scored the highest number of lawful votes cast by the King Makers' Committee and thus selected by the said King Makers' Committee as Emir of Zazzau, the Plaintiff has thus acquired, vested right to the stool of the Emirship of Zazzau Emirate from the date of his selection (24th September, 2020) thenceforth;
- e. A DECLARATION that 14 days after the date of the Plaintiff's selection (24th September, 2020), by the King Makers' Committee of Zazzau Emirate as Emir of Zazzau, he is deemed appointed the Emir since the Governor has refused to appoint him as such within 14 days after his selection;
- f. A DECLARATION that the Plaintiff is the Emir of Zazzau and is entitled to all rights and privileges pertaining thereto.
- g. AN ORDER setting aside the purported appointment of the 11th Defendant (Ambassador Ahmad Nuhu Bamalli) as the Emir of Zazzau;

PLAINTIFF'S WITNESS STATEMENT ON OATH

- I, ALHAJI BASHARI AMINU, Male, Adult, Muslim, Nigerian citizen of Zaria, Kaduna, do make oath and states as follows:-
- 1. That I am the Plaintiff in this Suit and by virtue of my position thereof, I am conversant with the facts of this matter;

- 2. That I am a Prince of the Zazzau Emirate from the Katsinawa ruling house and I am entitled to contest the throne of the Emir of Zazzau and indeed contested at the last exercise. I am one of the Three (3) Candidates who went through the final screening exercise by the King Makers for the selection of the next person to occupy the throne of the Emir of Zazzau and I was duly selected having emerged with the highest number of scores.
- 3. That the 1st Defendant is the Governor of Kaduna State, the 2nd Defendant is the Secretary to Kaduna State Government, the 3rd Defendant is the Chief Law Officer of the Kaduna State Government, while the 4th Defendant is the Commissioner for Local Government and Chieftaincy Affairs, Kaduna State.
- 4. That the 5th Defendant is the Zazzau Emirate Council charged with the duty of conducting and coordinating all matters pertaining to the administration of the Emirate.
- 5. That the 6th, 7th, 8th, 9th and 10th Defendants are members of the King Makers' Committee of Zazzau Emirate Council.
- 6. That the 11th Defendant is the person unlawfully and unilaterally appointed by the 1st Defendant as the 19th Emir of Zazzau and whose said appointment is being challenged by me in this case.
- 7. That the stool of the Zazzau Emirate evolved under Native Law and Custom and consequently any appointment to fill the vacant stool of the Emir of Zazzau must be in compliance with the relevant Zazzau Native Law and Custom which provides that the selection of the Emir of Zazzau must be done only by the King Makers' Committee.
- 8. That the King Makers of Zazzau under Zazzau Native Law and Custom are:
 - a. Wazirin Zazzau;
 - b. Fagacin Zazzau;
 - c. Makama Karami Zazzau;
 - d. Limamin Jumma'a Zazzau; and
 - e. Limamin Konan Zazzau.
- 9. That the 1st Defendant, who is the Chief Executive of Kaduna State has a statutory duty to appoint a successor to the throne of the Emir of Zazzau based on the selection done by the King Makers' Committee, which is the only Body entitled to select a successor in accordance with the Customary

Law of Zazzau Emirate and the Chiefs (Appointment and Deposition) Law of Kaduna State.

- 10. That the erstwhile 18th Emir of Zazzau, Alhaji Shehu Idris, CFR, died on the 20th day of September, 2020.
- 11. That sequel to the death of the 18th Emir of Zazzau, Alhaji Shehu Idris, CFR and in particular on the 21st day of September, 2020, the Wazirin Zazzau and Senior Councilor to Zazzau Emirate (Alhaji Ibrahim Muhammad Aminu) on behalf of the Emirate Council, did a letter informing the 2nd Defendant of the demise of the Emir of Zazzau (Alhaji Shehu Idris, CFR) and further intimating the Government of Kaduna State that a vacancy has been created in the stool of the Emir of Zazzau occasioned by the death of the said 18th Emir of Zazzau.
- 12. That by his Letter dated the 22nd day of September, 2020, with Reference No. SSG/KDS/577/179, the 2nd Defendant in reply to the Council Secretary, Zazzau Emirate Council, gave the Emirate Council the "go ahead" to commence the process of selection of a new Emir for the Emirate.
- 13. That following the directive of the 2nd Defendant to the King Makers' Committee to commence the process of selection of the new Emir of Zazzau, 11 (eleven) people initially indicated interest in contesting for the throne including my humble-self.
- 14. That the 11 (eleven) candidates went through rigorous screening exercise by the King Makers' Committee.
- 15. That out of the Candidates who were screened by the King Makers' Committee, only three scaled through for the final voting stage. These are Alhaji Bashari Aminu, Iyan Zazzau (me); Mohammed Munir Ja'afaru, OFR, Mni, Yariman Zazzau and Alhaji Aminu Shehu Idris, Turaki Karamin Zazzau.
- 16. That after the screening exercise, the King Makers' Committee pruned down 3 (three) best qualified candidates for the final selection including me.
- 17. That on the 24th day of September, 2020 the King Makers comprising the 6th, 7th, 8th, 9th and 10th Defendants held a meeting for the purpose of selection of a new Emir of Zazzau whereat they deliberated and consequently voted. The result of the exercise showed the following as the scores;
 - a. Alhaji Bashari Aminu, Iyan Zazzau (me); 3 votes, scoring 89%;



- 21. That by the law, tradition and rules of natural justice, it is the person (candidate) who scored the highest number of lawful votes that must be appointed the Emir by the Governor of Kaduna State. That in this case, I am the person who scored the highest votes and ought to be appointed as the Emir by the 1st Defendant (the Governor of Kaduna State).
- 22. That by the result of the selection exercise by the King Makers' Committee of Zazzau Emirate as contained in their Report submitted to the Kaduna State Government, I was duly selected as the next Emir of Zazzau having scored the highest marks/votes.
- 23.That having regard to my deposition in paragraph 22 herein, the 1st Defendant is under a statutory duty to appoint me as the Emir of Zazzau...
- 24. That to my greatest surprise and disbelief, the 1st Defendant unilaterally, arbitrarily, unlawfully and contrary to equity and good conscience appointed the 11th Defendant as the Emir of Zazzau when the said 11th Defendant did not make the list of the 3 final shortlisted candidates for appointment as the Emir of Zazzau.
- 25. That since the 11th Defendant did not make the final list of 3 candidates selected by the King Makers' Committee of Zazzau Emirate, there is no basis whatsoever for his appointment as the Emir of Zazzau by the 1st Defendant
- 26. That I am deemed appointed as Emir of Zazzau within fourteen days after my selection by the King Makers' Committee of Zazzau Emirate, notwithstanding the 1st Defendant's refusal to so appoint me.
- 27. That in a futile attempt to give effect to the illegality surrounding the appointment of the 1st Defendant as the Emir of Zazzau, the 1st Defendant in an unusual lightning speed purport to gazette the said appointment vide Kaduna State Gazette No. 9 Vol. 54 dated the 7th day of October, 2020 but published on the 8th day of October, 2020.
- 28. That I claim against the Defendants jointly and severally as follows:
 - a. A DECLARATION that the Plaintiff to the exclusion of the 11th Defendant has been duly and properly selected as the Emir of Zazzau (Zaria) by the King Makers' Committee of Zazzau Emirate in accordance with the provisions of the Chiefs (Appointment Deposition) Law of Kaduna State and Zazzau Native



Law, Custom and Tradition on the 24th day of September, 2020;

b. A DECLARATION that the unilateral appointment of the 11th Defendant as the Emir of Zazzau (Zaria) on the 7th day of October, 2020, by the 1st Defendant when the 11th Defendant was not selected at all by the King Maker's Committee of Zazzau Emirate, contravenes the mandatory provision of the Chiefs (Appointment and Deposition) Law Cap 21 Laws of Kaduna State, rendering the said appointment irregular, unlawful, unconstitutional, unjust, inequitable and contrary to good conscience, and is therefore null, void and of no legal effect whatsoever;

c. A DECLARATION that the Plaintiff having been selected as the Emir of Zazzau by the King Makers' Committee of Zazzau Emirate on 24th day of September, 2020, is entitled under the Chiefs (Appointment and Deposition) Law of Kaduna State, to be appointed by the 1st Defendant (Governor of Kaduna State) as the Emir of Zazzau;

- d. A DECLARATION that having scored the highest number of lawful votes cast by the King Makers' Committee and thus selected by the said King Makers' Committee as Emir of Zazzau, the Plaintiff has thus acquired, vested right to the stool of the Emirship of Zazzau Emirate from the date of his selection (24th September, 2020) thenceforth;
- e. A DECLARATION that 14 days after the date of the Plaintiff's selection (24th September, 2020), by the King Makers' Committee of Zazzau Emirate as Emir of Zazzau, he is deemed appointed the Emir since the Governor has refused to appoint him as such within 14 days after his selection;
- f. A DECLARATION that the Plaintiff is the Emir of Zazzau and is entitled to all rights and privileges pertaining thereto.
- g. AN ORDER setting aside the purported appointment of the 11th Defendant (Ambassador Ahmad Nuhu Bamalli) as the Emir of Zazzau;
- h. AN ORDER setting aside/nullifying the Kaduna State Government Gazette No. 9 Vol. 54 dated the 7th day of October, 2020, but published on the 8th

October, 2020, appointing the 11th Defendant as the Emir of Zazzau;

- i. A PERPETUAL INJUNCTION restraining the 1°1, 2°1d, 3°1d, 4'th and 5'th Defendants from installing the 11th Defendant to the throne of the Emirship of Zazzau and or presenting to the 11th Defendant the staff of office;
- j. AN ORDER OF PERPETUAL INJUNCTION restraining the Defendants either by themselves, agents, privies, servants or through any other person or persons howsoever from treating, presenting or dealing with the 11th Defendant as the Emir of Zazzau;
- k. AN ORDER OF PERPETUAL INJUNCTION restraining the 11th Defendant (Ambassador Ahmad Nuhu Bamalli) from presenting himself to the 1st Defendant (The Governor of Kaduna State) for the purpose of being sworn in as the Emir of Zazzau or being presented with the Staff of Office thereto;
- I. AN ORDER OF PERPETUAL INJUNCTION restraining the 11th Defendant from parading, presenting or styling himself as the Emir of Zazzau or from putting on or wearing any paraphernalia or insignia of the Emir of Zazzau;

m. Cost of this action;
