## COURT ORDER

- 3. AND for such further order or orders as this Honourable Court may deem fit to make in the circumstance.

Came up for hearing on 19<sup>th</sup> October, 2020 before Honourable Justice K. Dabo – Judge.

After hearing 5 paragraphs affidavit in support of the motion exparte by S. Attung Esq, with Mercy Umaru Esq., and Y. B. Galadima Esq., counsel for the Plaintiff/Applicant.

## IT IS HEREBY ORDERED THAT:

I order that all the defendants/Respondents be served with the motion on notice and the originating process filed in this suit.

For the motion on notice dated 16<sup>th</sup> October, 2020, the defendants/ Respondents are given 6 days upon service on them of the processes, if need be, to respond to same.

Accelerated hearing is ordered for the motion on notice.

The principal parties in this case are hereby



ordered not to take any step to render nugatory the outcome of the motion on notice.

The date for the hearing of the motion on notice shall be the 27<sup>th</sup> day of October, 2020.
